A limited number of trailers are available for use with this Fuels Reduction Trailer Program. Trailer maintenance is required often with these type of dump trailers. Furthermore, the personnel assigned to this program are also active emergency responders, creating additional challenges for exact scheduling. Please be patient and remember this is a free program to you.

Due to the high volume, no guarantee of availability can be made. Please provide 2 or 3 dates you would like to use the service. Every effort will be made to accommodate one of those dates if possible. Request for use will be filled in the order they are received. **It can be anticipated that during our busy time of year, there may be a 6 to 8 week waiting list.** The maximum number of days a trailer can be made available for use is four (4). If it is not full after four days, it will be picked up and brought to the next person on the list.

Conditions for Use:

The yard debris shall consist of strictly woody, leafy vegetative material. Appliances, hazardous materials, liquids, auto parts, construction material, lumber, metals, plastic, rocks, concrete, animals, or any other man-made materials will not be accepted. A Fuels Management member will pick the trailer up and dispose of the material at no charge to the property owner. If there is any prohibited material in the trailer at the time of pickup, the team member will dump the trailer where it sits and remove the trailer.

The RELEASE OF LIABILITY for trailer use must be signed at the time the trailer is dropped off. It shall be understood that the receiving party is responsible for loading the trailer with the proper materials and takes full responsibility if improper materials are found at the time of pick-up and dumped on the property prior to removing the trailer.

Trailer Use Restrictions

The intent of the Central Lyon County Fire Protection District in providing trailers to the public is to create an alternate means of disposal of accumulated vegetation yard waste. To this end, the following items are prohibited from being placed in the trailer:

- Appliances
- Hazardous Materials
- Any liquid substances
- Auto Parts
- Construction Material
- Lumber
- Metals, Plastics, or other man-made materials
- Rocks, Concrete, or Dirt
- Animals
- Anything outside of the scope of vegetative materials

Vegetation yard waste shall be of such a size as to facilitate ease of disposal. Tree limbs and trunks shall be cut down to 6 ft. or less before being placed in the trailer.

Should there be a question as to the conditions specified above, please consult with a Central Lyon County Fire Protection District – Fire Prevention Division employee and/or its representative prior to, or at the time the trailer is delivered to your residence. Release of Liability
Use of Trailer

In consideration for being permitted to use a fuels management trailer provided by the Central Lyon County Fire Protection District, designed for the express purpose of disposing vegetation yard waste from individual, private parcels I, _____, on my own behalf as well as on the behalf of my heirs, next of kin, personal representatives and assigns, hereby agree as follows:

1. Trailer(s) will be used strictly for the purpose of removing and disposing of accumulated vegetation yard waste. Items listed on the attached document will not be allowed, and shall not be placed in the trailer(s). Should prohibited items be placed in the trailer(s), all items within the trailer(s) will be removed on site upon retrieval of trailer(s) by Central Lyon County Fire Protection District personnel and/or its representatives.

2. I, _____, will be the sole user and responsible party of the aforementioned trailer(s) until it returns and is in the possession of Central Lyon County Fire Protection District personnel and/or its representatives. I agree that I will not grant permission to any other person or organization to use the trailer(s). I also agree that the trailer(s) will not be removed from the location where it is originally placed by the Central Lyon County Fire Protection District. I understand the Central Lyon County Fire Protection District can remove the trailer(s) at any time.

3. In consideration of having this service provided to me free of charge, I hereby RELEASE and DISCHARGE the Central Lyon County Fire Protection District, its personnel, volunteers, officers and assigned representatives from any and all liability, losses, claims, demands or causes of action ("Losses") that I may hereafter have for injuries and damages arising out of my use of said trailer(s).

4. I further agree to indemnify, hold harmless and defend, not excluding Central Lyon County Fire Protection District's right to participate, Central Lyon County Fire Protection District from and against all liability, claims of actions, damages, losses and expenses, including but not limited to reasonable attorney costs, arising out of any alleged negligent or willful acts or omissions of me. I will not be liable for any attorney's fees or costs if Central Lyon County Fire Protection District chooses to participate with its own legal counsel.
